### BS 7671 AMENDMENT 4: WHAT COMMERCIAL CLIENTS SHOULD KNOW FOR 2026

BS 7671 sets the UK standard for electrical safety and efficiency. Amendment 4 updates the 18th Edition Wiring Regulations with new rules reflecting recent technology and risks, especially in commercial and industrial settings.

- Stationary secondary batteries for energy storage like solar PV and backup systems.
- Power over Ethernet (PoE), which delivers data and power over Ethernet cables, used in CCTV, access control, and smart lighting.
- Functional earthing for ICT systems to address safety in complex digital setups.

These changes support greener, smarter commercial installations that meet modern business needs.

#### **AMENDMENT 4 ALSO TIGHTENS RULES FOR:**

- Wiring in ferromagnetic enclosures to reduce electromagnetic interference.
- Special locations such as swimming pools, medical sites, and other high-risk environments.

This is crucial for commercial sites like leisure centres, hospitals, and data centres requiring careful planning.
